## 85,000 Square feet Next Door?! Nickie Miner

Benedict Canyon faces an enormous challenge for which the assistance and support of all hillside residents is requested. Your voice is vital.

Briefly, an 85,000-square foot project is proposed for Benedict Canyon, on a 5-acre parcel with a slope, accessed only by one long narrow, winding residential street. The size of the project has been compared to Hearst Castle. The application filed for a granted lot line adjustment for the project had misrepresentations. Benedict Canyon Association filed an appeal to reverse the lot line adjustment and to require a full

### **BASELINE HILLSIDE ORDINANCE ALMOST HOME**

On June 6, 2006 Councilmember Tom LaBonge introduced a motion calling for a comprehensive, citywide ordinance “to establish the appropriate size of single-family homes in flat and hillside areas.” Baseline size (floor area and height limits) and configuration were to be determined in relation to individual lot size and slope as well as the character and scale of the

neighborhood. Out of this motion grew two separate ordinances – the Baseline Mansionization Ordinance (for the flats), which became law on June 29, 2008, and the Baseline Hillside Ordinance (BHO), which was adopted by City Council on March, 18, 2011.

The Hillside Federation, along with an overwhelming number of representatives from hillside communities, has been an active and enthusiastic participant throughout the lengthy BHO process. This process included five kick-off meetings, six citywide workshops, two Planning Commission hearings, two PLUM hearings, and three City Council hearings.

In spite of the overwhelming support, some of the original City Planning staff recommendations were scaled back, and some of the grading protections were removed. At the first City Council hearing, Councilmember Koretz made amending motions to include additional protections for 100% slopes. After final passage of the Ordinance in front of City Council on March 18th, it was signed by Mayor Villaraigosa on March 25 and will go into effect on May 9, 2011.

Thanks go to Councilmembers Tom LaBonge and Paul Koretz, and to City Planners Vince Bertoni, Charlie Rausch, Erick Lopez, and Jennifer Driver (who were

honored at the Federation's holiday party).

Although the Baseline Hillside Ordinance is a great start, there's still more work to be done: a Retaining Wall Ordinance, a View/Ridgeline Ordinance, and a Stream Ordinance would provide much-needed additional protections for hillside areas. The Federation looks forward to continuing with this important collaborative effort.

## **Federation Victory for the Mulholland Bridge**



In a stunning victory for the Mulholland Design Review Board (MDRB) and for the Hillside Federation, Caltrans withdrew its plan to realign the historic Mulholland Bridge across the 405 freeway. The process actually works!

Numerous community groups wrote to the MDRB to express their opposition to Metro's unilateral decision to move the bridge with no public input and no new EIR. The Hillside Federation, Santa Monica Mountains Conservancy, Bel Air Skycrest Property Owners Association, Brentwood Residents Coalition and Canyon Back Alliance were among those who weighed in on the change.

The Mulholland Design Review Board, charged with protecting the scenic rural aesthetic of Mulholland Drive, established a list of conditions that Caltrans and Metro had to meet before they would approve their plan to move the bridge. One of those conditions was the requirement that they hire a world-class architect to design the new bridge. That condition would have been more costly and would have set the project back a year. Ultimately Metro decided to stick to the project that had already been presented to the public and reviewed.

Congratulations to the Mulholland Design Review Board and all who supported them for making the system work.

## **Your ACE in the Hole Meaningful Code Enforcement**

Have you ever been frustrated because you saw a code violation, reported it and nothing happened? Building and Safety issued a citation to the property owner, but nothing happened. The scofflaw got off scott free.

The problem is that under current law, the violator has to be prosecuted in the court system, a costly and time-consuming process. The City Attorney's Office, under the direction of Jane Usher, has been developing a new way to enforce the code that will not involve the court system. Supervising Assistant City Attorney Tina Hess will explain the new system, known as Administrative Citation Enforcement (ACE) to the Federation at Wednesday's meeting. The City Attorney's Office is seeking community support for ACE when it goes to City Council. Learn what it's all about and tell the City Attorney your opinion.

**Draft Minutes  
March 2, 2011**

**I. Call to Order:** President Marian Dodge called the meeting to order at 7:05 pm. Members and guests introduced themselves.

**Guest Speakers:**

**A. LA Clean Sweep - Ron Kaye**

Ron Kaye declared that City Hall has failed the citizens of Los Angeles and urged us to challenge incumbents. In the CD 14 race LA Clean Sweep is starting ads for Ramirez tomorrow. In CD 4 they have endorsed Stephen Box and have a media blitz this weekend. Ron is amazed that newspapers have endorsed several newcomers.

The real battle will be in 2013 with six council seats open. They need to recruit qualified candidates. The Mayor's race will be a free-for-all.

**B. Ads in Parks - Dennis Hathaway, Ban Billboard Blight**

Dennis Hathaway asked how many had seen the So Cal Connected series on city parks. A link is posted on the RonKayeLA web site. The program described the Parks Commission plan to allow the LA Parks Foundation to place ads for the new Yogi Bear movie in three city parks last October. Councilmember Koretz moved to veto the recommendation because it violated the city's billboard ordinance. Barry Sanders, who is President of the Parks Commission and President of LA Parks Foundation and a retired attorney from Latham & Watkins, maintained that it wasn't an ad if it thanked a corporation for its sponsorship. After the So Cal Connected piece aired, the LA Parks Foundation removed the marketing materials from their web site. Marian referred people to the articles in the February Hillside

Federation newsletter and in the Friends of Griffith Park newsletter.

Hathaway said communities need to have a voice in how their parks operate. There needs to be a public discussion.

LaMar Advertising gave free billboard space to Councilmember Jose Huizar. LaMar has been working behind the scenes to get the city to allow them to remove small billboards and put up 150 new ones, 50 of which will be digital.

Hathaway urged everyone to let your councilmember know how you feel about advertising in parks and billboards in general. He would like the city to ban ads for alcohol and depictions of violence on street furniture and on any public property like they did in San Francisco. He has had no luck reaching Tom LaBonge who chairs the Parks Committee.

**C. Save Franklin Canyon - Ellen Scott**

Hastain Trail is a popular hiking trail in Franklin Canyon near Coldwater and Mulholland where the old Doheny Ranch was. Everyone thought it was Santa Monica Mountains Conservancy land until a bulldozer showed up. Ellen didn't know what to do so she sat in front of the bulldozer with a sign. Councilmember Paul Koretz got a stop work order when he discovered the owner's permits had expired. Save Franklin Canyon wants to become a 501(c)(3) to collect enough donations to purchase the property. They are researching wildlife and endangered species. They are doing a full title search. SMMC mentioned eminent domain. Wendy-Sue Rosen volunteered to work with them to partner with an existing nonprofit to raise funds and awareness.

Shawn Bayliss from Koretz' office said the 4200-foot long wall 23 feet high doesn't meet standards. The Baseline Hillside Ordinance (BHO) will go into effect in about



45 days. The owner will have to deal with today's rules. Nickie Miner urged them to attend the City Council meeting Friday to show support for the BHO.

## **III. President's Report**

Marian announced that Gillian Calof, the rep from Residents of Beverly Glen, had a baby.

AEG will try again to get the EIR for the stadium in LA waived by the new legislature. The Federation has resubmitted its signature to a petition to oppose the waiver. State Senator Pavley sent a note stating that she agreed with our position.

Marian would like to add a section on the web site with a history of the Federation and a list of past presidents. She needs help getting the information. Wendy-Sue Rosen said Alan Kishbaugh wrote an article on the accomplishments of the Federation. Marian would also like to post official letters so that people can read about the positions the Federation has taken. Everyone liked these proposals.

There was a discussion over the placement of Federation contact information, officers, and members in the newsletter. It was decided that it was important to include that information and it should be placed on one of the inside pages.

Charley Mims moved that a link to the Friends of Griffith Park web site be added to the Federation web site. The motion passed.

Marian announced that KCET's *So Cal Connected* is airing another episode of "Show Me the Money" on police and fire pensions tomorrow night. Charley Mims asked people to listen carefully to which pensions they are

referring to because the city has many different plans for its public employees.

Marian asked if members are interested in receiving e-mails about articles on open space and parks. Yes.

### **A. Nominating Committee**

Marian appointed Dr. Niles Chapman, Don Andres, and Wendy-Sue Rosen to the Nominating Committee. They will produce a slate of officers for the elections in April. The slate will be e-mailed to members in advance.

### **B. Treasurer's Report**

Since Treasurer Dan Palmer was not able to make it, Marian made the report. Membership renewal checks have not yet been deposited.

## **IV. Old Business**

### **A. Mulholland Bridge realignment update -**

The Federation voted unanimously to demand a new EIR for the realignment of the Mulholland Bridge and wrote a letter to the Planning Department. The bridge is going to remain where it is; it won't be realigned. The Mulholland Design Review Board was really angry with Metro for changing the plans which wasted a lot of tax dollars and split the community. Charley Mims commented that the MDRB's requirement that they hire a world-class architect to design the new bridge was too hard to meet. Wendy-Sue Rosen thanked Marian for writing the first letter on the project; it started the process that led to Metro dropping their plans.

### **B. Baseline Hillside Ordinance update**

Everyone was urged to attend the City Council meeting on Friday for the approval of the BHO.
