## Wildfire Season Impacts Los Angeles Area with Major Fires

California wildfire season traditionally begins in the fall each year, as Santa Ana winds in southern Cal (and Diablo winds in the north) elevate ever-present risk of fire in brush areas. The Los Angeles Times has published and continues to update a statewide map of major California fires (available at: <a href="https://www.latimes.com/wildfires-map/">https://www.latimes.com/wildfires-map/</a>).

Recent major wildfires within the City of Los Angeles include:

- The Getty Fire, 745 acres in Brentwood between the I-405 freeway and Bundy and Kenter Canyons, destroying 12 homes and damaging 6 more;
- The Barham Fire, 80 acres near Warner Brothers Studios in the Hollywood Hills;
- The Palisades Fire, 42 acres south of Palisades Drive in Pacific Palisades.

Nearby in Ventura County even larger fires burned. These include the Maria Fire near Santa Paula (approximately 10,000 acres), the Easy Fire in Simi Valley (more than 1,800 acres). While these local fires pale in comparison to Sonoma County's Kincade fire (almost 78,000 acres), based on recent history it is clear wildfires will continue for the foreseeable future.

Join us this month as we receive updates on the Getty Fire and on the revised Berggruen Institute project (located on the ridge above where the Getty Fire started).

## Hillside Federation September 17, 2019 Draft Minutes

#### I. Call to Order

Vice President Mark Stratton called the meeting to order at 7:09 pm. Members and guests introduced themselves.

**Guest: Fernando Morales** — Supervisor Kuehl's Office

Fernando described the changes in the Los Angeles County voting system for the 2020 election. There will be 150 polling centers throughout the county and people will have 11 days to vote. More information is available at the website VSAP.lavote.net.

Fernando distributed the County's Quarterly Update on Homelessness. The county needs more housing units. The hardest element of the homeless crisis is increasing the number of units available; it takes quite a while for them to come online. But whenever a new site is proposed, all of them are considered.

#### II. Approval of Minutes

The September minutes were approved as written.

#### III. Officers' Reports

<u>A. President's Report</u> — Marian Dodge reported on behalf of Charley Mims

The Federation received a happy Rosh Hashanah card from Councilmember David Ryu (CD4). Beloved Chief Park Ranger Albert Torres died on October 12 after falling ill during the Saddleridge Fire.

#### IV. Old Business

A. Weddington Golf Course — Chip Meehan, Save LA River Open Space

Community members have fought to have the property protected and maintained as public open space. Community members are concerned that Harvard-Westlake School, which purchased the property, is planning development of the property that is out of scale with its surroundings, including a 500-space subterranean garage. Because of the high water table, water will have to be pumped out of the subterranean garage and locker rooms. They are not changing zoning but requesting a CUP. Harvard-Westlake is now the largest land owner in Studio City. Harvard-Westlake held invitation only meetings with alumni to garner support for the project. Save LA River Open Space is working with Councilmember Krekorian to scale back the project. The golf course will be removed, but they are trying to save tennis courts for public use.

<u>B. 3003 Runyon Canyon Rd.</u> update — Don Andres, Joan Cashel

Three organizations wrote letters opposing the project. The community has hired an independent consultant to analyze the DEIR. The owner did not tell the Federation about a tunnel. The plan would consider the existing Headley/Handley House as an accessory dwelling unit (ADU), even though the maximum size of an ADU is 1200 square feet. The Headley/Handley House, at more than 2,000 sq. ft., doesn't qualify.

#### V. New Business

<u>A. 11472 W. Laurelcrest Dr.</u> — Diana Zogran, Sunshine Hills Neighborhood Residents Assoc.

The Board of Public Works (BPW) approved the tree removal permit and determined the project was exempt from CEQA. Community members have argued the project is within a special Sensitive Natural Community with numerous protected Coast Live Oaks, and a California Bird Refuge. Sunshine Hills filed an appeal with the BPW, supported by the Santa Monica Mountains Conservancy and are seeking support from the HF in opposition to this project. The council file for the appeal is CF 19-1134.

**MOTION**: Don Andres moved that the Federation write a letter to CM Krekorian in support of Sunshine Hills' appeal of the 11472 Laurelcrest Dr. project on the grounds of CEQA and the protected tree ordinance. The motion passed.
