# **Senate Bill 9 Implementation Memorandum**



From Los Angeles City Planning February 10, 2022

<u>Senate Bill (SB) 9</u> took effect on January 1, 2022. The bill establishes a ministerial process for approving two-unit developments and lot split parcel maps for qualifying projects located on lots zoned for single-family. City Planning has prepared (alongside the Building and Safety and

Housing Departments) <u>a memorandum</u> to summarize the eligibility criteria and standards, in addition to outlining the application process for interested applicants.

**Key Provisions** 

Note: Included below is a partial list of provisions. Please consult the memorandum for detailed instructions.

Eligible projects are limited to sites zoned A1, A2, RA, RE, RS, R1, RU, RZ, and RW. Sensitive sites (i.e. wetlands, floodways, conservation areas, habitat areas, and certain historic designations) are prohibited from utilizing SB 9.

SB 9 projects are prohibited from demolishing or altering the following housing types:

Housing subject to a recorded covenant, ordinance, or law that restricts rents to levels affordable to persons and families of moderate, low, or very low income

Housing that is subject to the Rent Stabilization Ordinance (RSO); and

Housing that has been occupied by a tenant in the last three years.

SB 9 units must be permitted a minimum of 800 square feet but may be larger in size if the unit is below the maximum allowable Residential Floor Area for the zone.

Units resulting from SB 9 projects cannot engage in short-term rentals.

While most two-unit projects proposed under SB 9 can proceed directly to <a href="Plan Check">Plan Check</a>, applicants are encouraged to meet with City Planning prior to filing if the project is located in a <a href="plan overlay">plan overlay</a>. (Consult the <a href="Zoning Information and Map Access System">ZIMAS</a>, to verify.) The following <a href="Fact Sheet">Fact Sheet</a> was drafted to provide more details to commonly asked questions.

# **Ridgeline Protection Ordinance Update**



From Los Angeles City Planning February 3, 2022

The preservation and protection of Los Angeles's ridgeline areas is an important effort that would advance the City's broader goals of resilience and fighting climate change. Upon further consideration, and in light of the feedback we've received, City Planning has determined that, in lieu of an independent <u>Ridgeline Ordinance</u>, the best way to holistically analyze and successfully address Los Angeles's ridgelines would be through the <u>Wildlife Pilot Study</u> program—a parallel but related work program.


The Wildlife Pilot Study is a proposed ordinance that introduces development regulations aimed at protecting and preserving Los Angeles's natural resources, habitats, and ecosystems. Ridgelines, as potential corridors for wildlife mobility, have been considered a critical resource under the proposed Wildlife Pilot Study. The draft ordinance for the Wildlife Pilot Study aims to incorporate ridgeline protections, in keeping with the City's overall goals on sustainability.

By consolidating ridgeline protection efforts into the Wildlife Pilot Study, City Planning will be incorporating the ecological, biological, and environmental resources currently analyzed under both ordinances and apply them uniformly across Los Angeles's ridgelines and Wildlife Pilot Study area. As opposed to having two separate ordinances, the revised ridgeline protections will be folded into the Wildlife Pilot Study and advanced by a single ordinance. This unified approach

will allow for continued progress while ensuring a more effective set of regulations within hillside communities across the Study Area.

The revised Wildlife Pilot Study Ordinance is slated to be released in the spring of 2022. It will address the public comments we've received and incorporate many of the original considerations from the preliminary Ridgeline Ordinance. # **SOHA Mourns Passing of its President, Richard Close**

Our community and Los Angeles lost a tremendous leader, Richard H. Close, President of the Sherman Oaks Homeowners Association (SOHA), who passed away on Monday. SOHA's Board of Directors mourns Richard's death and recognizes that we and the community we serve were fortunate to have someone so skilled and dedicated at our helm.

Richard brilliantly held the volunteer position of SOHA President since 1977 – more than 40 years. His leadership and guidance steered SOHA to become one of the most powerful non-profit community organizations in California. The New York Times referred to Richard as the "King of the

Valley." Former Councilmember Tom LaBonge once said "If you look at the history of Los Angeles in 50 to 100 years, you will find the name of Richard Close. He has been and is an impactful community leader, not just in his neighborhood of Sherman Oaks, but for all of Los Angeles." It was Richard's dedication that built SOHA into the strong, vibrant community force that it is today.

Richard Close worked tirelessly for Sherman Oaks and the Sherman Oaks Homeowners Association. In his role as a community leader and SOHA President, Richard worked on the passage of Proposition 13, a ballot initiative which immediately reduced California property taxes by more than 50 percent. He worked on Proposition U which impacted development citywide. Another contribution was getting a carpool lane on the 405 freeway through the Sepulveda Pass.

Richard's community work was accomplished alongside his distinguished career as an attorney. His law practice focused on land use entitlements, administrative and regulatory law, project development and financing, manufactured-housing communities, governmental relations, and advocacy. Richard was nationally recognized for his expertise on legal issues related to his housing and real estate specialties. The legal, political, and business communities each recognized Richard's skills in creating community opportunity and valued his ever-astute judgment. His work will continue to have a lasting and beneficial impact on the residents of Los Angeles County.

Although he excelled in every area of his life, he always made it clear that it was his family that came first. Richard is survived by his wife Sally, his children Matthew and Abby, and his four grandsons. In lieu of flowers please direct donations to the UCLA Health Extensivist Program.

# Woodside freezes SB 9 projects, citing an exemption for mountain lion habitats

Mountain lions and housing policy aren't often uttered in the same sentence, but that was the case last week in Woodside.

On Jan. 25, the town <u>put an indefinite hold</u> on all housing projects under Senate Bill 9, <u>California's new split-lot law</u>, in Woodside, according to Town Manager Kevin Bryant. The state legislation took effect last month and allows homeowners to split single-family lots and construct up to four residential units.

Town officials found a clause in the law that prohibits development in areas identified as habitats for protected species. Mountain lions are a protected species because they are a candidate for the California Endangered Species Act and Woodside, in "its entirety" is a mountain lion habitat, according to a <a href="Jan. 27 memo">Jan. 27 memo</a> from Town Planning Director Jackie Young. The Fish and Game Commission planned to release a decision on the animals' status in November, but the agency has yet to make that determination.

## CLAW featured in LA Times' column "The Wild"





Candid cameras in the wild can tell us so much about our habitat. L.A. is no exception. CLAW, or Citizens for Los Angeles Wildlife, released a 2021 highlight reel of footage from webcams posted in natural spaces in the eastern Santa Monica Mountains, roughly between the 405 Freeway and Griffith Park. The season-by-season wildlife sightings are amazing, many showing bobcats and coyotes with the skyline of downtown L.A. in the background. But the area is fragmented in terms of creating a functioning corridor for wildlife to roam, something the organization has been working on. "CLAW sponsored the original L.A. City Wildlife Corridor Motion in 2014 ... which has taken eight years to become a draft wildlife ordinance," co-founder and CEO Tony Tucci wrote in an email. "Our organization fulfills our mission with a focus on three tenets: conservation, education and advocacy. Our Nature Cam Program fulfills all three." ## Save the Stahl House

The historic Stahl House, which is on the National Register of Historic Places and is one of the most famous architectural homes in the world and a Los Angeles Historic-Cultural Monument, **IS POTENTIALLY AT RISK!** 

For over 60 years, our iconic and beloved home has perched atop a dramatic cliff overlooking all of Los Angeles.

The hill upon which the Stahl house rests is fragile and set in a designated landslide area and earthquake zone by both the City of Los Angeles and the State of California. Numerous catastrophic slides have already damaged or destroyed other nearby homes.

So far we have been lucky, and the house has survived and has been available for the enjoyment of all Angelenos and architecture-lovers from around the world.

Shockingly, the City of Los Angeles has recently approved development of the lot directly below our house that would remove over 200 dump trucks of dirt from right below our historic dwelling and build enormous walls that are many multiples of what the building code allows. **We believe that this presents a serious risk to the Stahl House.** 

WE HAVE APPEALED THE CITY'S ILL-CONCEIVED DECISION AND NEED YOUR ASSISTANCE TO HELP STOP THIS DEVELOPMENT.

Please urge the City Planning Commission to grant the Doheny Sunset Plaza Neighborhood Association's and our appeal of this decision. Please also urge our Councilmember, Nithya Raman, to support this appeal, as that will greatly increase our odds of success.
