

## Hillside Federation Monthly Meeting

#### I. Call to Order

<u>Mike Feuer</u> - Candidate, LA City Mayor Mike Feuer stated that he has a proven track record of leadership; he is the only city councilmember to run unopposed for a 2<sup>nd</sup> term, and he is the only City Attorney to win an award.

- C. CD4 Update Mashael Majid/Mehmet Berker Mashael Majid and Mehmet Berker thanked Travis Longcore, President of BABCNC, for the cooperation during redistricting. CD 4 supports naming SMMC as a Trustee Agency and expanding Hillside Construction Regulations.

Lindsey Horvath, West Hollywood City Council member, attended, stating that she is running for LA County Supervisor, on a listening tour.

- D. <u>SB 9 and 10 Update</u> Jamie Hall Jamie Hall made a presentation to BABCNC. The city needs to incorporate exemptions

that are in the law and make sure that ineligible projects don't proceed. A councilmember needs to make a motion to map the areas that are exempted.

E. <u>Flight paths from Burbank & Van Nuys airports</u> - Travis Longcore Charley Mims asked Travis Longcore, President of BABCNC, to discuss effects of overflights and noise on the parklands and the people that use them. The MRCA has opted not to join the lawsuit objecting to the changes because it is a social justice issue. The request is to return the flight paths to original pending environmental review which was never done before the flight paths were changed. Without objection, the Federation will ask the MRCA to put the reconsideration of the item on their December agenda.

## IV. New Business

#### A. HR 1354 - Wendy-Sue Rosen

HR 1354, by Congressman Ted Lieu, would extend the Santa Monica Mountains National Recreation Area south to include Santa Monica Bay to San Pedro, excluding the port. Senator Padilla wants to include the bill in his package. Wendy requested a letter of support from the Hillside Federation. The letter was supported without objection.
