I. Call to Order

The meeting was called to order by President Charley Mims at 7:03 pm.

Guest Series: Getting to Know Candidates

Rick Caruso - Candidate, LA City Mayor.

He stated that "For change I'm the right candidate." He served on the DWP Board for 13 years: "We have a lot of water that's wasted; we need to use recycled water on landscaping." On placing commercial properties in residential zoning, he stated "the hotel project is highly problematic." "Our downtown convention space is archaic." Asked if he would support the Santa Monica Mountains Conservancy as a trustee agency, Caruso said he would. Asked if he would support permanent protected status for mountain lions; Caruso said he loves animals.

Assemblymember Laura Friedman - Candidate, AD 44

Friedman explained that she is currently in the 43rd district, but because of redistricting, is running for the 44th district, which is further into the San Fernando Valley. She will no longer represent Griffith Park. Friedman stated that we need to be careful where we develop housing in the hillsides. We need to upgrade fire codes. Friedman voted against SB 9, stating that we do need more housing but we need to be sensitive to the areas that don't have adequate ingress and egress.
