I. Call to Order

President Charley Mims called the meeting to order at 7:05 pm.

IV. Old Business - (taken out of order) Harvard-Westlake River Park Project - Alan Dymond

The DEIR confirmed that the fire station has to be moved. The artificial turf is made of PFAS, toxic forever chemicals. PEER, Public Employees for Environmental Responsibility, is hosting a symposium on Sunday, Nov. 6., Christian Science Church across from Weddington.

Candidate Series: Jacqui Irwin - Assembly District 44 (now includes Pacific Palisades & Brentwood)

Priorities: education, environment, public safety, fire safety, open space. Jacqui said that she voted against bills that take away local controls for housing. Jacqui was not aware that the Burbank flight path had been relocated. Nancy Frawley: Assistant District Director Nancy.frawley@asm.ca.gov

CD 5 Update - None

CD 4 Update: Mehmet Berker -

We expect a new staff report for the Wildlife Ordinance to be out this week or next. The next step will be City Planning Commission meeting in November. CD 4 is working on speed mitigation on Mulholland. There will be staff changes in CD 4; Mehmet will be taking over parks and working on open space. Mashael Majid is the lead on the Open Space Element.

A. President's Report - Charley Mims

Mulholland Scenic Design Review Board hearing: The city will comply with the judge's directive; they are not appealing. Alan Kishbaugh stated that the city is mute; we've heard nothing from them. They have seen an increase in cases.

A. Mulholland Design Review Board Moratorium: Don Andres (See President's Report)

B. 3003 Runyon Canyon Road: Joan Cashel, Don Andres - Nothing new.

C. Safe Roads and Wildlife Protection Act (AB2344): Marian Dodge - Signed by the Governor.

D. Zoo Vision Plan: Marian Dodge - Comments have been submitted; we are waiting Final EIR from BOE.

- E. Mount St. Mary's University Project: Jamie Hall - Mt. St. Mary's will try to get some issues dropped.
- F. Curtis School Project: Wendy-Sue-Rosen - They have filed an appeal to get the same conditions that other schools have, eg. Cannot rent their facilities for filming, for commercial uses. No construction and no special events shall be permitted during high fire hazard/red flag days. A phone number shall be posted and visible at all times during construction. The Mulholland Place fencing, constructed within the public right of way, must be removed. If in the future Curtis decides to construct fencing in the public right of way, it must apply for a revocable permit from the Bureau of Engineering with notice to the Santa Monica Mountains Conservancy and adjacent community.

MOTION: Wendy-Sue-Rosen - That the Hillside Federation join the appeal of the Bel Air Skycrest Property Owners Association, Brentwood Residents Coalition, Bel Air Knolls Property Owners' Association. Motion passed.

- G. SB 9 and SB 10- Jamie Hall - nothing new.
- H. Hollywood Sign Lighting – Jeff Swofford - will present next month.

V. New Business

- A. Wendy-Sue Rosen - The Attorney General issued new guidelines for building in fire zones. Jamie pointed out that you can avoid EIR by saying everything is exempt.
- B. Jamie Hall: there are discussions about increasing the number of City Council members.
- C. Marian Dodge: Griffith Park is celebrating P-22's 10th anniversary in the park on October 22.
