Raman's committee assignments: Housing and Homelessness (Chair), Energy and
Environment, Public Works, Ad Hoc City Government Reform
89 projects have been approved; 135 affordable units; $25 \%$ are affordable housing units.
Wildlife Ordinance: Planning is still working on CPC comments and preparing a version to submit to PLUM.
CD 5 (Yaroslavsky) has some continuity with Dylan Sittig and Jarrett.
A gondola to Dodger Stadium is proposed by Frank McCourt, former owner of the Dodgers who still owns the parking lot.
The gondola component of the LA Zoo Vision Plan is gone.

Robert Schlesinger: A study of a deceased bobcat showed rodenticide in its system. We need stronger controls on rodenticides.

## A. Mulholland Design Review Board Memorandum - Don Andres

Alan Kishbaugh hasn't heard anything from the City about the MDRB right to review projects in the Outer Corridor. The MDRB needs a member who is a landscape architect or someone with environmental credentials.
B. 3003 Runyon Canyon Road - Joan Cashel, Don Andres - No update.

## C. Billboard Blight - Marian Dodge

The Coalition for a Beautiful Los Angeles will send out an action alert on Metro's Transportation Communication Network project. TCN would build 97 full-sized digital billboards at freeway interchanges and on major streets, undermining the city's ban on billboards. At Wendy-Sue Rosen's request, CM Bonin had it pulled from the consent calendar at the December meeting. It will be on the Metro agenda Friday, January 27. [Note: The meeting was actually Thursday, January 26.] Comments should be sent to TCN@Metro.net.
D. Zoo Vision Plan - Marian Dodge - The final EIR has not been released yet.

## E. Mount St. Mary's University Project - Wendy-Sue Rosen - They are still litigating.

## F. Curtis School Project- Wendy-Sue Rosen

CD 4 helped get a much better project; however they are appealing to get some routine conditions added to the project.
G. Harvard-Westlake River Park Project - Alan Dymond sent a report to Charley.

The Studio City Neighborhood Council passed a motion opposing the project because of greenhouse gas production, artificial turf with micro plastics, light, noise, and traffic.
H. SB 9 \& 10 Update - Jamie Hall

The first SB 9 project in the Santa Monica Mountains is a test case. SMMC submitted a letter opposing the project. They hired a biologist to prove it is California walnut/oak
woodland. We need to tell our Councilmembers what we want to see, eg prohibited in VHFHSZ. There is only a trickle of SB 9 applications so far.

## I. Hollywood Sign Lighting - Jeff Swofford

Mayor Bass rescinded Garcetti's last minute Executive Order allowing the lighting of the Hollywood Sign. Hollywood United Neighborhood Council created an ad hoc to address issues with the Hollywood Sign. Linda Othenin-Girard said the ad hoc would not discuss the closure of the Beachwood gate. Charley Mims suggested a Dark Sky plan. The ad hoc made 25 recommendations. Proponents think the revenue from lighting the Sign could pay for mitigation of tourist traffic in the area.
MOTION: Marian Dodge moved and Jeff Swofford seconded that the Federation oppose the lighting of the Hollywood Sign. PASSED.
