# Hillside Federation February 21, 2023 via video conference Minutes

#### I. Call to Order

The meeting was called to order at 7:05 pm by President Charley Mims.

### Guest:

## Office of Senator Anthony Portantino - Declan Floyd

Senator Portantino introduced 31 bills last year. Bills of interest include:

- SB 2: Concealed carry permits sponsor Rob Bonta
- SB 98: Could bring 3 billion dollars for the schools
- SB 257: Women's follow-up tests should be covered by insurance
- SB 411: Allows neighborhood councils to meet virtually
- SB 422: CEQA review streamlining bill
- SB 538: Create office of a bicyclist czar

SB 691: Requires students K thru 2 grade to be screened for dyslexia Wendy-Sue Rosen requested a clarification of "streamlining of CEQA" since we see it as possible weakening of CEQA.

## CD 4 Update - Mehmet Berker

The Wildlife Ordinance is still pending before going to the Planning and Land Use Committee. Cahuenga 101 underpass: Inside Safe rehoused of 29 people; next step permanent housing. Hillside repairs near Summit Circle are wrapped up.

Motion CF 23-0142 Report back on goal of zero emissions of green house gas in city parks. Sepulveda Basin Vision Plan 23-0105 - Rescoping, restores ecology, serves as flood control Griffith Park: They are beginning the installation of T-gates, adding humps, speed feedback signs for the permanent closure of Griffith Park Dr. to private vehicles from Travel Town to the mulch facility.

Wildlife Ordinance: getting it scheduled to committee Motion on Senderos Canyon for report back to see if there is funding available to purchase the property as green space. They are looking for state funding. Charley Mims: LA County agreed to provide social services and mental services Nickie Miner - There is no enforcement on the Home Sharing Ordinance.

The Coalition for Beautiful Los Angeles filed a lawsuit against the city regarding the Sidewalk and Transit Amenities Program (STAP). Metro is still trying to put up 97 billboards. Eric Edmunds: The Sunset Strip is visual clutter; there is a live movie screen on a billboard.

D. Zoo Vision Plan - Marian Dodge - The Final EIR has not been released.

E. Mount St. Mary's University Project - Wendy-Sue Rosen - It is still in litigation.

F. Curtis School Project - Wendy-Sue Rosen - It should be scheduled at PLUM.

G. Harvard-Westlake River Park Project - Alan Dymond - The DEIR must be recirculated because many parts were missing. AB 1423 is going to try to ban the use of artificial turf which is made of "forever chemicals."

- H. SB 9 and 10 Update Jamie Hall not present Ellen Evans discussed a proposed lot split in DSPNA.
- I. Hollywood Sign Lighting Jeff Swofford

Jeff provided a draft HUNC Report on 25 recommendations for mitigating traffic around the Hollywood Sign.

J. Digital "Canvas" at 9176 Sunset Blvd - Ellen Evans DSPNA hired an illumination engineer. The Illuminating Engineering Society studies lighting zones from 0 - 4, 0 being the darkest, 4 being the brightest. West Hollywood is a 4; Times Square is a 4.

K. California High-Speed Rail Authority (CHSRA) Draft EIR - Kelly Erin Decker/Kit Paull - Not present.

#### V. New Business

A. EF International Language Campus - Shawna Marino, Education First VP

Education First is purchasing the American Jewish University Campus on Casiano. They provide English instruction to foreign students who either live on campus or with host families. They are not planning any major square footage additions. EF will be adding a pool and a basketball court. The architectural team, Gensler, will create a new front door, add native plants, add security enhancements, with 4 entrances and exits and up to 1400 students. There will be no more than 1000 students on site at any one time Monday through Friday. There will be up to 116 faculty and staff and up to five 22-passenger shuttle buses.

Charley Mims suggested the addition of solar panels but they have no plans to do so. Wendy-Sue Rosen suggested they meet with the Santa Monica Mountains Conservancy regarding permeable fencing and the installation of fire-spotting cameras.

B. Senderos Canyon - Wendy-Sue Rosen

Councilmember Yaroslavsky initiated a motion to seek funding for the purchase of Senderos Canyon as open space. CF 23-0129.

MOTION: Wendy-Sue Rosen moved that the Hillside Federation support CF 23-0129. The motion passed.
