PARKING LIMITS RAISE RED FLAGS IN THE HILLSIDES

A new LA law bans cars from narrow hillside roads on days when fire is a threat, raising the question "What to do with cars?"

The newly enacted city ordinance bans parking on narrow, winding hillside streets whenever the LA Fire Department issues a "red flag" fire warning. The law is designed to make it easier for fire trucks to navigate streets that are often lined with parked cars. But with up to 10 red flag days a year, usually during the Santa Ana winds of summer, residents wonder where they are going to park.

The City's Transportation Department has erected 2500 signs warning that vehicles parked on the streets on red flag days will be towed. It plans to install a total 5200 signs by the end of January.

Residents point out that many homes in hillside neighborhoods are built on small lots where usable land is at a premium. If homes have garages, they are relatively small and can't always accommodate more than one car - and that's if the owners haven't converted them into living space.

The ordinance was adopted by the LA City Council early in December, with little fanfare, at the request of the Fire Department.

Councilman Jack Weiss, who helped draft the ordi-

nance after consulting with hillside homeowners groups, said the new rules are crucial to better protecting hillside homes during major brush fires.

The LA Times reports that some hillside homeowners groups have expressed support for the parking ban, saying it's important to give firefighters the help they need to battle brush fires. These backers are said to doubt the rules will cause much inconvenience. Supporters note that local TV and radio stations already broadcast red flag warnings - and the city's website will also begin to note the warnings.

But one supporter said there could be a bright side to the new ordinance."Maybe it'll force some people to clean out their garages so they can park in them."

The Hillside Federation was not consulted about this ordinance, but has asked the Weiss office to contact us re the issue, and hopes someone from the Weiss office will be able to attend our January meeting.

CHARLES & LOTTE MELHORN OVERLOOK

The Santa Monica Mountains Conservancy opened its newest scenic overlook on November 30, dedicating a crescent-shaped stop on Mulholland Drive to longtime preservationists Lotte Melhorn and her late husband Charles Melhorn.

Beginning in the early 1970s, the couple lobbied the City Council and regional leaders to create the

Mulholland Scenic Parkway and to set aside small pockets along the road for visitors to stop and admire the view. Today the drive is one of the region's major tourist destinations, drawing visitors from around the world, according to the Daily News.

"Charlie and Lotte were among a small nucleus of people who saw the value of the road and the uniqueness of the road and planned to save it for future generations," said LA County Supervisor Zev Yaroslavsky. "You come to these overlooks during the summer or all through the year and hear maybe three or four languages being spoken," said Joseph Edmiston, Exec. Director of the Santa Monica Mountains Conservancy.

The new overlook is the eighth official stop on the drive, about halfway between Beverly Glen and Coldwater Canyon Boulevards, standing above million-dollar homes and a brush-covered slope that is one of the few natural wildlife corridors through the mountains.

It's also the third overlook named for Hillside Federation Officers, the others being Barbara Fine, and Nancy Pohl, all of whom were dedicated and committed to preserving the natural beauty of our mountains and the wildlife within them

10501 WEST SEABURY LANE

We have been informed that the applicant has withdrawn his application for this project.

A major influence on the outcome of this application would appear to be a letter from Vice-President Joan Luchs, writing for the Federation, to Ms. Lynn Wyatt, Office of Zoning Administration.

The letter is printed here, in part:

"After careful review of the proposed project, the Federation of Hillside and Canyon Associations is vehemently opposed to this application based on the fact that none of the requests can meet the required findings necessary for approval....it is our belief that the slope of the

lot as measured from the highest point of the lot within five horizontal feet of an exterior wall of the main building to the lowest point of the lot within five horizontal feet is less than 66% and therefore does not qualify for a building height in excess of 36 feet to 45 feet....the proposed project will be materially detrimental and injurious to adjacent properties, is very likely to cause an unsafe adverse impact when you consider the amount of grading."

The letter goes on to list impacts on specific adjoining properties, objects to overheight fences, and giving this property owner unfair advantages over neighbors. The application also requests construction of three retaining walls 10 feet tall, in lieu of a maximum of two as permitted, would not be in conformance with the General Plan, would adversely impact neighbors aesthetically and financially, and would create an unfair disparity.

RE SEABURY LANE

Dear Hillside Federation:

Recently, Beverly Glen had a major problem. A homeowner wanted to build an outsized house on Seabury Lane. The builder wanted to construct a 4600 sq.ft. house on a hill over 4 lots on Seabury Lane - a twisting, narrow street. The plan was for a house totally out of character with the neighborhood.

Joan Luchs came to our aid. Representing the Hillside Federation, Joan took absolute command of the situation and presented indisputable arguments of why this outsized mansion should not be built.

As a result of Joan's efforts, the builder withdrew his plans. She was overwhelming and powerful at the hearing, since she had all the facts, the laws, and the interpretation of the laws.

Thank you, Joan Luchs and the Hillside Federation, for your help re this proposed illegal construction.

East-west access across the Mulholland area will remain open throughout the period either via detours or partial detours. If you have questions, please contact the Bureau of Engineering's Project Engineer, Carlton Jones, at 213-485-0961.

A hillside washout within the Santa Monica Mountains has necessitated an Urgent Necessity construction project by the City of Los Angeles. The purpose of the project is to stabilize a hillside slope adjacent to Mulholland Drive on the north side of the Hollywood Hills. During the construction of the project, you may experience some unavoidable inconvenience.

The contractor will make every effort to minimize adverse effects of construction on all neighboring properties. Local access to residences for area residents will be provided throughout construction. Mulholland Dr. will be closed to through traffic at Skyline Dr. and Allenwood Rd. between Coldwater Canyon Dr. and Laurel Canyon Dr.

Mulholland Dr. will be closed at the project location for a week beginning in late December. A detour for local residents is provided on a Local Access Only basis. After the period of complete closure, one lane westbound will be open to traffic and eastbound traffic will be detoured for the remainder of the project.

SIMI HILLS

The following letter was received from the National Park Service:

"The National Park Service (NPS) in cooperation with the Santa Monica Mountains Conservancy (SMMC) announces the opening of those portions of the Simi Hills that have been affected by October's Topanga fire as of October 13, 2005. Previously closed on September 28, 2005 to protect public safety, the Cheseboro, Palo Comado, Liberty and Upper Las Virgenes Canyons are now open for restricted use. We expect the restrictions to continue for at least one year or until the area has had a chance to stabilize and begin the recovery process.

During the restriction period, the public must stay on established roads and trails and observe all posted closure signs. Access to the public parkland will be permitted from sunrise to sunset. And as always, motorized vehicles are not allowed beyond public parking facilities.

By complying with the restrictions, the public and park neighbors can play a vital role in the restoration process of our land, wildlife, vegetation, and cultural resources. Additional information regarding park conditions can be found at trailhead kiosks.

In the short term, visitors who recreate in the Simi Hills area should expect to see a blackened landscape with pockets of unburned vegetation. Many oak trees, while scorched, will survive as they have during past fires. Over time, the land will begin to change as vegetation resprouts, wildflowers bloom, and many wildlife species return to the area.
