### **UPDATE ON LAUREL CANYON SLIDE**

The City is currently working with the private property owners who are expected to do their own geology analysis. However the City is prepared to do something on their own should the private property owners be unable to correct this situation.

There is still a lot that is not understood about this slide, particularly the depth of the soil involved. Topos and boring tests are needed to determine the severity of the problem and the proposed solution.

Given the recent events in Laguna Hills and La Conchita, the City is concerned about the safety of the thousands of commuters who use this route and the immediately affected homeowners. They are also concerned about the safety of the engineers who must work on the site. Nevertheless, the City expects to return the road to north-south traffic soon, and the needed surveys to begin shortly, maybe as early as June.

We support any action that will lead to a quick, safe and effective solution.
