405 FREEWAY OUT OF THE LOOP

The Los Angeles Times article on February 17, 2007, shows funding for California freeways, but leaves Southern California's #405 - BETWEEN #10 and #101-OUT OF THE LOOP!

This 10-MILE STRETCH HANDLES 300,000 cars The project for carpool lanes - going Northbound on the 405, between the 101 and the 10 - had a price tag of \$950 million. It seems the City and County engineers had set a date for construction in late 2011. The California Transportation Commission told staff to bring this back in another year. The Commission, appointed by the Governor, also stated that "funds are not dispensed by how many people live in an area, but choose projects based on READINESS FOR CONSTRUCTION, DEMONSTRABLE CONGESTION RELIEF, CON-NECTIVITY BENEFITS AND GEOGRAPHIC BAL-ANCE". Well, if the City, County and State engineering staff, D.O.T., and Caltrans can't connect the dots to make a case for our VOTED BOND (transportation funds) of last November, THERE SHOULD BE SOME SERIOUS HOUSECLEANING OF EMPLOYEES WHO COLLECT SUBSTANTIAL SALARIES FOR SHOWING UP JUST 4 DAYS A WEEK. Supervisor Gloria Molina is quoted: "It's an insult to the people of Los Angeles County, and is unacceptable."

With the history of our Board of Supervisors asleep at the switch, it's no wonder Los Angeles traffic issues are only going from bad to worse! Bandages (dollars\$\$\$) for the Martin Luther King Hospital did not work - now it seems we aren't even getting a "bandage".

duced by Jack Weiss in Feb. 2006 asking the Planning Dept to prepare a report discussing the "feasibility of drafting a citywide ridgeline protection ordinance". Status: Unknown.

- 2. McMansionization Ordinance -CF# 06-1292 introduced by Tom LaBonge in June. 2006, requesting that the Dept of City Planning, in conjunction with the City Attorney and the Dept. of Building and Safety, be directed to prepare an ordinance amending the LAMC to establish the appropriate size of single family homes in flat and hillside areas. Status: Planning workshops were held last year re: homes in the flats; hillside areas still to be discussed.
- 3. Grading and Hauling CF# 06-1593 introduced by Jack Weiss and Wendy Greuel July, 2006 to request a report from Building and Safety within 60 days to look at various ideas to reduce the negative impacts of grading and hauling in our hillside areas. Status: Report submitted to PLUM in Dec. 2006 from Building and Safety with their responses. Report did not address any solutions. Report is available on-line at www.lacity.org or available by request from Carol Sidlow.
- 4. "Cumulative impacts" CF# 07-0161 introduced by Jose Huizar and Eric Garcetti- requesting that the Planning Dept. with the assistance of the City Attorney, prepare a report within 30 days to present to PLUM that provides an interpretation of the California Environmental Quality Act, relative to "cumulative impacts" and how this section is interpreted by City staff and its impact on development in hillside areas of the City. Status: we will monitor.

It is important that the Hillside Federation continue to monitor these proposals and to let our City officials know that we are involved and concerned.

ALERT TO ALL CROSS-MOUNTAIN ROAD COMMUNITIES - SEPULVEDA ENHANCEMENTS

(Time to Move Out of Town?)

It seems we had a brief success of holding off a Reversible Lane in a 1929 Tunnel that is in total disrepair - but this package has resurfaced, in a County and City project - W.O. #E1904736, and B.E. #114-07.

4 In this new package:

- ·Right turn pockets at Wilshire & Sepulveda
- ·Turning pockets between Moraga Dr. & Church Lanes
- -Add Northbound right turn lane at Skirball Center Drive
- ·Add third Southbound traffic lane North of Skirball Center Drive
- ·Create Reversible Lane in Tunnel at Mulholland & Sepulveda.

The City cover letter begins with "...proposing to enhance vehicular traffic...". Is "enhance" a new word to replace "increase"?

Grading and excavation, hauling soils, destruction/replacement of curbs, gutters and sidewalks, retaining walls, roadway re-alignment, relocation of power poles, street lights and traffic signals, new paving, new storm-water drain - which is just the tip of the iceberg.

So, when two lanes are closed down for this "enhancement" of Sepulveda - from 18 to 24 months, at least - where will the cross-mountain traffic go? You guessed it - Roscomare, Beverly Glen, Benedict Canyon - and any other road that goes over "the Mountain". Oh, add Calneva and Longview to the list! The Westwood and Brentwood Libraries did not have the documents for public review at the date of this writing:

What does Richman think of the AB 1381 Compromise legislation? "It's unconstitutional - It sets up an ambiguous management structure with no accountability. If we want to bring accountability to LAUSD ... it has to be broken up."

MOTIONS TO BE PROPOSED IN PRESIDENT'S SECTION OF THE BABCNC MEETING FEB. 28, 2007

- 1) The BABCNC supports the residents and Board of the Roscomare Valley Association, the Glenridge Association and the Bel-Air Association and CPOR (Committee to Preserve Open Reservoirs) in its study and conclusions regarding the Upper Stone Canyon reservoir. The options include covering it similar to a pool cover, a cement cover with water on top, three immense tanks buried underground, landscaping with native plants etc. etc. Cost of construction estimates range from \$14 Million to \$253 Million.
- 2) The fire department strongly recommends that hillside residents in the brush area acquire BARRI-CADE a product formulated from crushed diapers which when mixed with water provides a sponge like material to be applied with water upon the inci-

dent of an approaching fire. All fire trucks in the city of Los Angeles carry this product on their trucks. The motion is as follows: The Bel-Air Beverly Crest NC recommends that residents purchase the product BARRICADE either individually or in groups to help protect their properties.

- 3) Steven L. Robinson, a Helicopter Pilot III of the Los Angeles Fire Department has come up with a system which accurately predicts the spread of a brush fire by using computer equipment which can map a brush fire. At the moment, his group is searching for funding so that helicopters equipped with this equipment, which currently have to land to transmit their prediction, can stay airborne to transmit this information. The proposed motion is as follows: The BABCNC supports the efforts of Steven L. Robinson and Oscar A. Barrera, Senior Systems Analyst I of the LAFD to acquire the necessary equipment through the city of Los Angeles Budget to be able to transmit fire mapping information directly to a Command Center without landing. Cost estimates range in the \$750,000 to \$1 Million range.
- 4) The Roscomare Valley Association has requested that the road which some believe is badly in need of repaving be moved to a priority position on Council District 5's repaying list. Sharon Howard, BABCNC manager, to provide other requests received by BABCNC. The motion is that the BABCNC supports the RVA in its efforts to have the road repaved ASAP.
- 5) The President of the BABCNC wishes to make the following motion: The BABCNC thanks the Mayor of Los Angeles for his efforts to provide state funding for the HOV project on the 405 Northbound between the 5 and the 101.

California Assembly's gain, since Richman returned to Sacramento where he worked until last year. But as his tenure came to a close what alarmed Richman was the mounting debt and unfunded liabilities the state was accruing for retiree pensions and health care.

In addition to County and City liabilities, on the state level, California annually pays \$3 billion for pensions and \$6 billion for retiree health care - equal to the amount we spend on higher education. California has a total of \$250 to 300 billion in unfunded liabilities to pass on to its children. This comes at a time when the state requires \$150 billion in infrastructure improvements.

Now freed from elective office, Richman has established the California Foundation for Fiscal Responsibility to devise solutions to the looming pension and health care crisis. "I have no confidence the legislature will address these issues because it's controlled by public employee unions. The only way it will happen is through the initiative process.

Richman explained that he had tried while in the Assembly to divide LA's 720,000 student school district into smaller districts with no more than 50,000 students, but that his proposal was rebuffed by legislators afraid of confronting the powerful teachers' union. Richman said he and other legislators offered to establish an interim commission that would have allowed Mayor Villaraigosa to control the schools temporarily.
