The Federation of Hillside and Canyon Associations, Inc. (the "Hillside Federation") files this Rule 8.500(g) letter in support of the Petitions for Review filed by the Mountains Recreation and Conservation Authority ("MRCA") and Friends of the Hastain Trail ("Friends").

Identity and Interest of The Hillside Federation

The Hillside Federation, founded in 1952, is a non-profit social welfare organization representing 45 resident and homeowner associations with approximately 250,000 constituents spanning the Santa Monica Mountains. 
Friends of the Hastain Trail, et al., Amicus Letter in Support of Petition for Review October 5, 2016 p. 2

The Hastain Trail, the subject of the *Friends of the Hastain Trail* litigation, has been in use as a recreational hiking trail by members of the public for more than five decades. The 2.3 mile loop trail is located in the heart of the eastern Santa Monica Mountains within Franklin Canyon Park. It is a beautiful and important resource for both nearby and distant community members, including children. Franklin Canyon Park provides habitat for many species of birds (Red-tailed Hawks, American Kestrels, Cooper's Hawks, Screech Owls, Long-eared Owls, and California Quail), mammals (coyotes and bobcats), frogs, salamanders, and snakes. In addition, the park and trail are a showcase for local flora, including California Black Walnut, Coast Paintbrush, Coastal Wood Fern, Coyote Brush, Narrow-leaved Milkweed, and other plant species.


The Hastain Trail is an important recreational resource. In one of the most park-starved dense cities in the nation, the loss of such an important resource so close to dense urban areas would be hard-felt. This is all the more so because the trail provides such a unique opportunity to experience the local natural environment while also enjoying remarkable canyon, City, and ocean views, which extend as far as Catalina Island on a clear day.

Unfortunately, the trial court judge is the only judicial officer in this case who had the opportunity to visit the Hastain Trail. Now that this Court must consider whether saving the Hastain Trail is of sufficient importance to justify review, the Hillside Federation believes pictures best convey that which is at stake for the general public.









If the majority opinion is not reversed, this important public resource will be lost forever. For these reasons, the Hillside Federation therefore respectfully requests that this Court grant review.
